### <u>Progress made over the last month on action plan steps reflective of our CCSU</u> goals, curriculum work, MTSS/MTSSB-instructional framework

## All Learners Network -

We continue to work with Kate Hughes from the All Learners Network as we continue to incorporate UDL best practices into our Math instruction. Kate completed the first phase of classroom observations in our Pre-K and 3⁄4 classrooms on October 23rd. Kate is supporting our teachers in incorporating UDL strategies, sequencing and strategies for multilevel classrooms, and creating opportunities for student engagement and student agency. Kate will return on December 4th to complete observations in our 1⁄2 and % classrooms and to provide teachers and staff support toward our school wide Math learning goals.

### Peer Observation Workshops-

In alignment with our UDL Math work with ALN, we are consulting with Margaret Maclean to build an observation based teacher peer support system at Peacham. The purpose of this work is to provide teachers with peer modeling support in order to give them first hand examples of how to put theory into practice. We are working with Margaret during early release in-service with our next meeting on November 3rd utilized to build specific systems, protocols, and structures for peer observational support systems.

### **UDL Collaborative Team-**

As a schoolwide collaborative we are working to more deeply instill UDL ideologies into our classrooms and our schoolwide culture and practices. We are doing this through instructional modeling at the school level and in collaboration with our CCSU partners. Our work with Margaret Maclean aligns with our UDL implementation through creating peer observational systems so that we can serve as hands-on, observable resources for one another. UDL at a glance

### Place Based Learning Seminar-

The focus point which connects our UDL work and our UDL practices in the classroom is place based, hands on learning. Experiential learning and thematic learning serves as the through line which helps students connect the curricular outcomes to tangible, real world experiences. It is our goal to create equity and opportunity for each and every one of our students and to ground our UDL teaching practices within experiential, hands-on, thematic, and place based learning opportunities. I will be attending the place based learning seminar on November 14th along with a group of our teachers in order to expand our knowledge and cultivate new ideas to strengthen experiential learning opportunities for our students.

## **Building Maintenance and Security Updates**

### Security Protocols and Procedures:

We will be working this year with Mark Mooney, retired Principal of Twinfield school to revise all Peacham school emergency and safety protocols. This work is being completed district wide.

### Secure Facilities and Community Facility Use:

We are formally approved to be designated as an emergency shelter by the Red Cross. Mark Tucker will review the agreements, and after his review is complete, we will present the proposal to the board for review.

### **Building Projects and Facility Upgrades:**

### Door Replacements (December)

All interior classroom doors will be replaced with fire rated doors and installed and wired with a magnetic lock security system. In addition, the two vestibule doors will be replaced and placed on a magnetic lock system, creating a safe corridor at the school entrance. This will allow the office to admit visitors into an enclosed and secure location without them having access to the rest of the school. This feature is a vital component in the process of making our school as safe as possible for students and staff.

- 1. **Superintendent Office:** Now that Mark Tucker is back part time, we are working collaboratively to ensure the continued smooth operation of the SU. We are dividing up the responsibilities and workload until Mark gets the all clear to return full time. We are both committed to the support of all staff, students, families, administrators and boards.
- 2. Budget: Mark and I have had regular meetings with Mike Concessi to review and develop budgets with as much information as we have available. Mike is working hard to make realistic, accurate projections about both revenues and expenses for the upcoming school year for the SU and each of its districts. We will be attending a two-day conference titled "Effective Practices in School District Fiscal Planning and Management" at the beginning of December. This professional development opportunity is designed for superintendents and business managers, and sponsored by VSA and VASBO.
- 3. **Threat Assessment:** Mark and I attended a webinar through the FBI related to hoax threats. It was informative and timely, given the events that unfolded in Twinfield last month. The webinar was targeted at law enforcement, but provided a useful perspective to us as school leaders.
- 4. PCBs: Mark is continuing his efforts to advance the decision making process for the Cabot gymnasium. Mark has also spoken with the consulting engineer about Corrective Action Plans (CAP) for Danville and Twinfield. The source testing at those two schools suggest straightforward remediation options, but this cannot proceed until DEC has a formal CAP so that they can authorize the removal of the PCB source material. Mark has pressed for this to be resolved before June 2024.

### 2. AOE Updates

a. The FY25 Act 173 Service Plan documentation was uploaded to the AOE by the October 20, 2023 deadline. As Mike Concessi mentioned during budget discussions, extraordinary reimbursement is received after costs exceed \$66,206.
