<u>Progress made over the last month on action plan steps reflective of our CCSU</u> goals, curriculum work, MTSS/MTSSB-instructional framework

Peer Observation Workshops and UDL implementation-

As the next stage in our peer observation work our staff will be focusing on elements of observable UDL best practices in our building. Teaching staff will be conducting scheduled observations and debriefings with teaching partners to observe and give specific requested feedback. Observable elements of the observations will then be utilized to highlight best practices in localized Peacham staff development. Our next step moving into February and March is to have teachers observe and collaborate with like staff from other buildings in order to continually develop and expand our skills in UDL implementation.

- 1. **January Focus** Budgets . . . and starting to look at what the Legislature will be up to in this session. I expect a fuller briefing in the next couple of weeks.
- 2. PCB Testing At this time we have a pretty good understanding for how to remediate PCBs in the three schools. What we are lacking is a Corrective Action Plan for each site that will actually *allow* us to remediate. The scale of the challenge is different in all three schools, with Cabot facing the most complex and expensive remediation need for its gym. Our consulting engineer has recommended that Danville skip the Evaluation of Corrective Action Alternatives (RCAA) step and go straight to a Corrective Action Plan (CAP). That recommendation was accepted, and we are waiting for a draft CAP for Danville. No additional action on Twinfield or Cabot.
- 3. Required Policy Work following Legislative Session S.138 the School Safety Bill, required us to adopt two policies by August 2023. The SU Board adopted those policies on behalf of the Districts at its June meeting. We are still waiting for guidelines for developing the required All-Hazards Emergency Operation Plans spelled out in the legislation. Latest from the AOE is to expect these updated guidelines in early January. The plans have to be in place by June 30, 2024; we will make best effort to meet that deadline, given that we were supposed to have had the guidelines in late summer.

Student Services Board Report January 2024

1. CCSU Updates

- a. During the most recent early release day, paraprofessionals were provided the opportunity for training by our speech language pathologists and occupational therapists on how various communication, sensory, and motor challenges can impact students in the classroom and how they can support them.
- b. The student services and curriculum departments continue to collaborate with district leaders to create a true MTSS model throughout the SU.
- c. Student services, curriculum, and IT meet regularly to review technology requests to ensure requests meet data privacy requirements as well as to ensure they are in alignment with all departmental goals.

2. AOE Updates

a. Special educators are working with building based test coordinators to ensure students have appropriate accommodations for upcoming state testing.

3. Of Note

a. I would like to recognize our speech language pathologists and occupational therapists for creating and providing professional development for our paraeducators. Thank you Tracy Winot, Heather MacDonald, Jennifer Sweet-DeMasi, Jennifer McCarthy, and Kelsey Shea for your efforts!

Families purposefully come to raise their kids here and often come back to be a part of our community. Two of our school board members even went to Peacham School and have returned. The community is strengthened by the bonds we develop in our school.

We want to share sincere gratitude to Sam McLeod and his staff at Peacham Elementary School. In addition, we thank Mark Tucker and his whole team at the CCSU Central offices for their unyielding commitment to all the kids in the supervisory union. As our budget not only funds the 64 kids at the school, we support over 50 more Peacham kids in the surrounding middle school and high schools. As you may know, Mark Tucker is retiring this year, and we could not be more grateful for his hard work these last seven years.

This year we will graduate nine students, sending them off to various middle schools around the northeast Kingdom. We are lucky to have excellent choices and appreciate that families can tailor their students' educational experiences to their needs.

We are still emerging from the pandemic and are finding the transition to be more difficult than anticipated. Kids and teachers continue to need more support and unfortunately this year the school budget will go up significantly. Much of this increase in budget is out of our control, due to raising tuition costs in the middle and upper schools, as well as increased healthcare and benefit costs for our dedicated teachers and staff.

Our building is in good shape. The solar panels on the roof continue to offset our electrical cost, and the pellet heater system is running smoothly. We were one of the districts in the supervisory union that did not have any PCBs in our building. Noting some of the challenges the rest of the SU is having, we feel fortunate that our building is doing well. We have updated the security and replaced all the doors this year.

This year we have celebrated many community gatherings and developed some new traditions. Thanks to Sam's diligent outreach, the Community Lunches have been well received, and individual classes have initiated two holiday food banks. It is wonderful to see the engagement of our kids, staff and community members.
